Annexure-I

Guidelines for Engaging Physiotherapists on Hire basis under Samagra Shiksha

1. Eligibility Criteria:

The candidate must have passed Intermediate with Bachelors degree/Masters degree in Physiotherapy (BPT/MPT) from a recognized

institution/Affiliated to any University recognized by UGC.

2. Honorarium:

Rs. 12,000/- pm per Physiotherapist for 12 Camps per month @ Rs.1,000/- per each Camp). The honorarium will be given to the physiotherapists for camp based on budget allocation by the Project Approval Board, MHRD, Government of India.

3. Mode of work:

The physiotherapist will be covered 3 IERCs (Bhavitha Centers) which are located in 3 mandals of the concerned district. Roles and responsibilities will be attached in the **Annexure-II**

4. Tenure:

The Physiotherapist position is a not a sanctioned post so that the position will be engaged on purely hire basis. The position is not comes under outsourcing or contractual basis.

The physiotherapist will be provided services to the Students with Special Needs for the period of 10 months only of the concerned academic year.

The authority has a right to terminate at any time without any intimation to the candidates

4. Application: Enclosed in Annexure-III

5. Eligibility:

Applicants are having Bachelor of Physiotherapy/ MPT qualification are eligible

Applicants having working experience in Samagra Shiksha would be given first preference.

5. Selection Procedure:

The Physiotherapists selection will be done purely on the merit basis (Marks obtained in BPT/MPT) and priority will be given for those who are possessing higher qualification & working experience in Samagra Shiksha would be get added advantage.

6. Selection Committee:

Constitute the following 5 Men committee under the chairmanship of Joint Collector for the selection of Physiotherapists.

The Selection committee will be shortlisted the candidates and shall observe the following abilities among the applicant.

1	Knowledge on Anatomy and excise therapy
2	Role of Physiotherapist for improving mobility skills among Students with Disabilities
3	Behavior approach and communication skills of the candidate
4	Practical knowledge on different Physiotherapy techniques related to improving CwSN health

7. Age Limit:

Above 18 Years and up to 60 years

8. Allotment of Mandal:

IERCs (Bhavitha) will be allotted by way of counseling on the basis of merit list The APCs has to provide identity cards to all the selected Physiotherapists clearly mentioning the validity period i.e., up to 30th April, 2024.

Annexure-II

Roles & responsibilities of the physiotherapists:

- The Physiotherapists engagement is purely temporary on hire basis for a limited period of one Academic Year (10 months only for the concerned academic year).
- Every Physiotherapist will be allotted an IERC cluster (cluster of three Mandals/Bhavitha Centers) and he/she should conduct 4 Physiotherapy camps in every Bhavitha Center per month and he should conduct a total of 12 Camps per month for three Mandals.
- The physiotherapists have to work under the control of MEO of that IERC Mandal.
- The Physiotherapist shall conduct Physiotherapy Camps in Bhavitha Centers on Monday, Tuesday and Wednesday in every week. The timings of Physiotherapists to provide physiotherapy shall be from 9.00AM to 4.00PM.
- It shall be the job of Physiotherapist to identify the requirements of children like Physiotherapy, Surgeries, Appliances, etc.
- The Physiotherapists shall hold the responsibility for the results due to the therapy given by him/ her and also maintain child-wise progress in the office of MEO in the prescribed format which is supplied to them by

Samagra Shiksha.

- The Physiotherapist shall invariably hold the identity card with him/ her during the duty time. They shall affix a copy of certificate of their professional qualification in the office of MEO/ IERC at a visible place.
- The Physiotherapists should be tolerant, patient and should build a rapport with parents of CwSN and should guide them whenever they required.
- The Physiotherapist and concerned IERPs should intimate one day prior to the parents of CwSN about the Physiotherapy Camp conducting in Bhavitha Center.
- Every Physiotherapist should maintain a Physiotherapy Register which includes the particulars of CwsN attending the Physiotherapy Camp along with the signatures of the parents.
- The Physiotherapists should Co-operate the IERPs and should participate in all the programmes conducted in Bhavitha Centers.
- Every Physiotherapist should get approval of Leave one day prior from the concerned MEO under intimation to the concerned IERP and shall conduct the Camp on alternate day and the same should be intimated to the parents of CwSN.
- They have to prepare mandal-wise profiles of children attending for Physio Therapy within 15 days of joining.
- They shall attend all the trainings provided by Samagra Shiksha.
- They shall attend the monthly review meetings at APC & submit the reports in the formats provided by Samagra Shiksha.
- They shall follow all the instructions of Samagra Shiksha, District Office issued from time to time.
- The Samagra Shiksha, District office will have the right to terminate the services of the Physiotherapists at any point of time without assigning any reason, if found that the performance of the Physiotherapist is not up to the mark.
